格洛丽亚·马卡帕加尔·阿罗约从政前是经济学家,在菲律宾多所大学(包括国立大学)担任经济学教授。在学界工作期间,阿罗约积极致力于建立良好的菲中关系。40多年前在中国尚未对外开放的20世纪70年代,阿罗约作为菲中互解协会的主要成员,有幸受邀访问了中国北京、上海、广州、杭州和大寨等地。阿罗约的父亲迪奥斯达多·马卡帕加尔曾在1961-1965年间担任菲律宾总统,因此菲律宾的一些资深政治家招募她竞选参议院议员,她的从政生涯由此开始。阿罗约在2001-2010年间担任菲律宾总统;2010-2019年阿罗约曾三次担任菲律宾众议院议员;2018年4月,阿罗约当选为博鳌亚洲论坛理事会成员;2018-2019年,她当选菲律宾众议院议长,直至宪法规定的三届任期结束。

Gloria Macapal-Arroyo began her career as an economist and a professor of economics at a number of universities in the Philippines, including the country's state university. Even when she was still in the academe, she was already involved in fostering good relations with China. More than 40 years ago. as an active member of the Association for Philippines-China Understanding, she visited Beijing, Shanghai, Guangzhou, Hangzhou, and Dachai in the 1970's, when China had not yet opened up to the world.

Her father Diosdado Macapagal was President of the Philippines from 1961 to 1965. Thus, it seemed natural that at some point, some of the senior politicians in the Philippines recruited her to run for Senator, and that launched her political career. She was President of the Philippines from 2001 to 2010. She was elected as a member of the Board of Directors of the Board Forum for Asia in April, 2018. She served as Speaker of the Philippine House of Representatives in the 2018-2019 session, until the constitutionally mandated end of her three terms.

Mr. Michael W Lodge of the U.K. serves as Secretary-General of International Seabed Authority since 2017. He was Deputy to the Secretary-General prior to his election. He received his LLB from the University of East Anglia, and has an MSc in marine policy from the London School of Economics and Political Science. He is a barrister of Gray's Inn, London. He has also held appointments as a Visiting Fellow of Somerville College, Oxford (2012-2013), an Associate Fellow of Chatham House, London (2007) and a member of the World Economic Forum's Global Agenda Council on Oceans (2011-2016). With 28 years of experience as a public international lawyer, Michael Lodge has facilitated high-level multilateral and bilateral negotiations at international and regional level. His significant achievements include his pivotal role in the ISA from its inception in 1996 and in helping to create and implement the first international regulatory regime for seabed mining. He also contributed to the future security of global fish stocks by leading the process to create the Western and Central Pacific Fisheries Commission from concept to its establishment as the largest regional fisheries management organization in the world, also serving as the interim executive director of the Commission. Mr. Lodge has published and lectured extensively on the international law of the sea, with over 25 published books and articles on law of the sea, oceans policy and related issues.

In 2008, he was appointed as a member of the national committee on Oman continental shelf project in the Ministry of Foreign Affairs. In 2011 he was appointed as ambassador in the office of the continental shelf and maritime affairs in the Ministry of Foreign Affairs in Oman in charge of the geological/geophysical survey and follow up on the multi-disciplinary tasks required for the Omani continental shelf extension project. In 2021, he was appointed




Mr. Wang Sheng is the Party Secretary and the President of the National Institute for South China Sea Studies (NISCSS). He is the graduate student supervisor of the Hainan University. He is also a Distinguished Professor, a senior foreign affairs worker in China and an expert on emergency response in Hainan. He graduated from the Victoria University of Wellington, New Zealand, with a Master's degree in Applied Linguistics in English. He studied at the Harvard Kennedy School, Duke University in the United States and Oxford University in the United Kingdom.

Mr. Wang has devoted his career to foreign affairs and South China Sea research for more than 20 years, immersing himself in a number of research fields including international relations and regional security strategy, China's rights and interests in the South China Sea, island development, and the Hainan Free Trade Port. He has published more than one hundred academic papers and a dozen of works, including "Non-traditional Security and the South China Sea Regional Development", "Suggestions on the Regular Maintenance of Fishing Rights in the South China Sea", "A Few Thoughts on Addressing the South China Sea Disputes", and "A Study of the Philippine's Claim to the Islands and Reefs in the South China Sea in View of the Presidential Decree No.1596".

For many years, Mr. Wang worked on the front-line for China's rights and interests in the South China Sea and the stability of that sea, pushing for exchanges and cooperation with other countries and regions around the sea. He helped cities in Hainan build 65 sisterhood relationships with provinces and cities overseas, including nine pairs of sisterhood relationships with cities in other coastal countries of the South China Sea, which has greatly expanded Hainan's international exchanges and cooperation; and led efforts to resolve a number of incidents and cases on the South China Sea.

Committed to serving and fully leveraging the Boao Forum for Asia (BFA), Mr. Wang has worked hard on the front-line for the BFA for 23 years, making an outstanding contribution to the BFA's inception and development, and to the launch of its platforms for opening-up and international cooperation such as the "China-ASEAN Governors/Mayors Dialogue", the "21st Century Maritime Silk Road Islands Economic Cooperation Forum", the "Free Trade Ports: The Global Trend" Session, the "Path Towards SDG 2030: Poverty Reduction and Rural Sustainable Development" Session, the "BFA Global Tourism Forum" and the "BFA South China Sea Subforum". Mr. Wang is editor-in-chief of the Book Series Commemorating the 20th Anniversary of Hainan's Engagement in the Boao Forum for Asia and, through his involvement in the preparation and design of the BFA Theme Park, made a further contribution to the understanding of the BFA's history among the people of Asia and the world. In June 2021, BFA Secretary-General Li Baodong presented Mr. Wang a BFA Certificate of Appreciation, stating that "On the occasion of the 20th anniversary of the Boao Forum for Asia, we highly acknowledge and commend your immense contribution and dedication to the inception and development of the Forum."



He was also the founding editor of China: An International Journal. His papers have been published in journals such as Comparative Political Studies, Political Science Quarterly, Third World Quarterly and China Quarterly.



He leads a world class team of specialists that are undertaking a diverse range of projects on land-to-ocean leadership, climate change and the Law of the Sea, BBNJ and so on. He is the author/co-editor of 14 books and over 100 scholarly articles on oceans law and policy. He read for his PhD at the School of Law Trinity College Dublin, he has been a Senior Visiting Scholarin-Residence at the University of California, Berkeley, and a Visiting Scholar at the 'Centre for Oceans Law and Policy' at the University of Virginia. Prior to his academic career, he was a permanent staff member at the European Commission and undertook over 40 missions on behalf of the European Institutions to the Member States of the EU, the US, Canada, Central America as well as to African countries. During his previous career in the Irish Naval Service, he won an academic prize at Britannia Royal Naval College and held a number of appointments ashore and afloat, including membership of the Navy's elite diving unit.







Between 2007-2009, Dr.Sorajak was appointed Executive Director of the International Institute for Trade and Development (ITD), a public organization in Thailand jointly established by UNCTAD and the Thai Government. Between October 2012 - January 2014, he was President of Thai Airways International Public Company Limited. He has taught international air law, public international law, and international law for natural resources in several universities in Thailand since 1993. He was born in Calgary, Alberta, and attended the University of Calgary where he received his B.A, and subsequently did graduate work at Carleton University in Ottawa, and at the University National in Lima, Peru. Under Prof. Houlden's leadership, the China Institute has focused on contemporary China studies, with an emphasis on Canada's trade, investment and energy linkages with the People's Republic of China. 




菲律宾海岸警卫队指挥官 **Jay Tristan Tarriela** Commander, Philippine Coast Guard





2013年1月,"中国南海研究院北京分院"正式成立。2016年3月,由研究院与印尼战略与国际问题研究中心联合发起,东南亚多家重要智库共同参与的"中国一东南亚南海研究中心"正式成立。2017年6月,研究院被确定为新增国家高端智库建设培育单位。2018年10月,研究院获批设立博士后工作站。

近年来,边海院承担了中央外办、发改委、外交部、自然资源部、水利部、商务 部等部门和单位委托的多项研究项目。




#### **About CIBOS**

Founded in 2007, CIBOS is a leading multi-disciplinary research center and think-tank in China that aims to deepen understanding of boundary and maritime issues, to facilitate peaceful resolution of boundary and maritime disputes and to enhance exchanges and cooperation across national boundaries, through research, consultancy, teaching and training activities. Its key research areas include land boundary disputes settlement and cross-border cooperation, maritime delimitation, maritime dispute resolution and maritime cooperation, governance of the polar regions and international cooperation, and application of science and technology in delimitation and management of national boundaries. ### 海南热带海洋学院简介

海南热带海洋学院由海南省人民政府、国家海洋局、中国海洋石油总公司、三亚市人民政府、三沙市人民政府等单位共建的全日制公办普通本科省属高校,是外交部、教育部"中国—东盟教育培训中心"、教育部"教育援外基地",是国务院学位委员会批准的硕士学位授予单位,是上海合作组织大学中方成员院校,也是海南省中南部少数民族地区的人才培养摇篮和知识创新、社会服务、文化传承、国际交流与合作的基地。

学校共有全日制在校生 18276 人,现有硕士学位点 10 个,设立二级学院 19 个, 开设本科专业 53 个,专科专业 9 个,学科涵盖文学、理学、工学、管理学、教育学、 历史学、艺术学、法学、农学等 9 大门类,初步形成了以海洋、旅游、民族、生态为 特色的学科专业体系。

学校先后与五大洲和港、澳、台 65 个国家和地区的 139 所高校和教育机构开展合作与交流,签署合作协议 162 份。派出 900 多名学生到 20 多个国家和地区做交换生、汉语志愿者、共同培养硕士生、游学生及海外实习生。接收 25 个国家来华留学生 320 名。多次组织和承办国际论坛、国际研讨会及国际国内合作交流会议。

学校围绕"建成一所立足海南、面向南海,国内有影响力、国际有知名度的热带特色鲜明的高水平应用型海洋大学"的愿景目标,为建设经济繁荣、社会文明、生态宜居、人民幸福的美好新海南作出更大的贡献。



### **Hainan Tropical Ocean University**

Hainan Tropical Ocean University (HTOU) is a full-time public university jointly constructed by Hainan Provincial People's Government, China National Offshore Oil Corporation, State Oceanic Administration of P. R. C. and Sanya Municipal People's Government. It is granted as "China-ASEAN Education and Training Center" by Ministry of Foreign Affairs and Ministry of Education, China, "Educational Aid Center" by Ministry of Education, China, master degree awarding institution with the approval of the State Council Academic Degree Committee and member university of Shanghai Cooperation Organization University. It serves as a cradle of talents cultivation for the minority area of south central Hainan and functions as a center for knowledge innovation, social service, culture inheritance and international cooperation and exchanges.

HTOU now has 18,276 full-time students and 19 schools offering 10 master programs, 53 undergraduate programs and 9 post-secondary programs. Its educational disciplines have expanded into 9 fields which are Liberal Arts, Sciences, Engineering, Management, Pedagogy, History, Art, Law and Agriculture. It has formed a disciplinary system pattern of marine, tourism, ethnology and ecology.

HTOU has established partnerships with 139 universities from 65 countries and regions. 162 cooperation agreements have been signed. Over 900 students have been sent to 20 countries and regions as exchange students, Chinese volunteer teachers, master students and intern students, and to attend study tour. The university has received 320 international students from 25 countries, and has hosted dozens of international forums, seminars and international and domestic cooperation and exchange conferences.

HTOU will carry the vision of building the university into a high-level applied ocean university with distinctive tropical characteristics, domestic influence and international popularity, based on Hainan and facing the South China sea, to make greater contributions to constructing Hainan into a province with prosperous economy, social civilization, pleasant environment and happy residence.
